Tax Incentives

ABOUT US



The Erie County Industrial Development Agency (ECIDA), is an independent, public benefit corporation created in 1970 by an act of the New York State Legislature to promote and assist private sector industrial/business development, create jobs, incentivize urban core development and create economic well-being for the people of Erie County.

The ECIDA is sanctioned by the State of New York to administer tax incentives to qualified business applicants located in Erie County. To receive a tax incentive, a business <u>must make a substantial private investment such</u> as business expansion, adaptive reuse of an abandoned structure, job creation, or other criteria as defined by State Statute and ECIDA policy. Incentives from the ECIDA are <u>not</u> grants, loans, cash or forgiveness of previous tax payments; rather, ECIDA tax incentives help businesses bridge gaps in financing large capital projects, so they can reach their expansion goals by allowing a limited discount of future sales, mortgage or property taxes related to the project.

The ECIDA helps businesses leverage millions of dollars of their private investment in Erie County, preserving and creating jobs and redeveloping abandoned commercial structures into vibrant neighborhoods and commercial districts. Most importantly, IDAs help our local communities remain competitive when employers are looking for regions to expand and/or create jobs; incentives often determine whether a business chooses to locate, expand, or in some cases avoid closure and job losses in a particular municipality.

The ECIDA does not receive operating funds from any tax revenue stream, such as property, schools or sales taxes. The ECIDA is funded by collecting administrative fees from the private sector businesses that receive ECIDA incentives, which eliminates the need for a taxpayer-supported administrator of Erie County IDA incentives. Fees collected by the ECIDA also help fund the redevelopment of abandoned industrial sites into thriving commerce parks, such as Renaissance Commerce Park, located on the site of the former Bethlehem Steel campus. ECIDA employees are not City, County or State employees, and they are not a part of the New York State pension system.
