project consisting recording facilities, corporate and business meeting space,

and rehearsal, performance and event space (the "Improvements"); and (iii) the acquisition and installation by the Company of certain items of machinery, equipment and other tangible personal property (the "Equipment", and collectively with the Land, Existing Improvements and the Improvements, the "Facility").
