There being a quorum present at 12:09 p.m., the Meeting of the Compensation Committee was called to order by its Chair, Mr. Poloncarz.

**MINUTES**

The minutes of the July 15, 2021 Compensation Committee meeting were presented, and upon motion made by Mr. Lipsitz, and seconded by Sister Denise, and as thereafter voted upon, the minutes were unanimously approved.

**REVIEW OF PROPOSED 2022 COLA RECOMMENDATIONS**

Mr. Cappellino reviewed proposed the 4% COLA salary adjustments. General discussion ensued.

Ms. Gallagher moved and Mr. Blue seconded to approve of the 2022 COLA recommendations. Mr. Poloncarz called for the vote and the motion was unanimously approved.

## **REVIEW OF ECIDA 2021 PERFORAMNCE INCENTIVE PLAN RECOMMENDATIONS**

Mr. Cappellino reviewed the 2021 Performance Incentive Plan results and recommendations. Mr. Poloncarz spoke in favor of the proposed performance incentive plan payments, but noted the President/CEO had voluntarily removed himself from bonus consideration. Ms. Gallagher and Mr. Schoetz both spoke in favor of Mr. Cappellino being eligible for bonus consideration. Members expressed support for making a performance incentive payment to Mr. Cappellino's and concluded that it should be considered at a subsequent meeting.

Mr. Blue moved and Mr. Lipsitz seconded to approve of the 2021 Performance Incentive Plan recommendations. Mr. Poloncarz called for the vote and the motion was unanimously approved.

## **COMPENSATION STUDY**

Mr. Cappellino informed committee members that it was timely to perform an updated ECIDA employee compensation study, and noted that the study will be undertaken during the third quarter of 2022. The committee confirmed that the study should include CEO compensation and should also consider total compensation, including benefits, and not just salaries.

There being no further business to discuss, Mr. Poloncarz adjourned the meeting at 12:27 p.m.
